Introduction

The continuous publication "Applied Research" publishes original and not published elsewhere articles of researchers, academics, practitioners, and students in Lithuanian or English.

It is a multidisciplinary scientific journal; therefore, it publishes research articles from all areas (and fields) of science approved by Order No. V-93 of the Minister for Education, Science and Sport of the Republic of Lithuania of 6 February 2019:

- Natural Sciences,
- Technology Sciences,
- Medical and Health sciences,
- Agricultural Sciences,
- Social sciences,
- Humanities.

Manuscript submission procedure

Manuscripts submitted to the editorial board should be written in academic language, and the text should be edited, free of spelling, punctuation, and style mistakes. The scope of the article is 7–8 pages (including figures and tables, etc.). The manuscripts shall be accepted for publication only if all the conditions listed below are met:

- 1. Authors submit manuscripts that meet the specified requirements. They are responsible for ensuring that the article contains original research data and the co-authors of the article agree on its content and authorship. After submitting the manuscript, the authors submit the original of the letter of guarantee signed by the authors.
- 2. Reviewers shall be appointed to review the articles that meet formal and scientific requirements. The reviewers' names shall not be disclosed to the authors. The reviewers shall submit article reviews within two weeks. If necessary, the article with reviewers' comments shall be returned to the authors for revision. The amended text should be returned within two weeks. If the authors do not agree with the substantial remarks provided by the reviewers, they should substantiate the arguments by sending them to the editorial board in writing.
- 3. The peer-reviewed article shall be published with the approval of the editorial board of the journal.

Requirements for the structure

The structure of the article should be as follows:

1. **Title of the article, the author(s)** of the article and the *institution(s)* represented.

- 2. **Abstract**. The abstract should provide a brief overview of the content of the article, the relevance of the problem(s) researched, the research methods used, and the results obtained. The text of the abstract should be clear and concise. The scope of the abstract is limited to 2000–2200 characters.
- 3. **Keywords.** The abstract should be followed by 3–5 keywords denoting the most important features of the topic.
- 4. **The introduction** of the article shall describe the problem analysed, its relevance, and the level at which the problem has been researched. This part presents the research statement (aim), the subject of the research, its objectives, and research methods.
- 5. **The analysis** should provide a description of the research. The methodology used and the analysis shall be presented in sections and subsections with titles. In the case of empirical research, the main part should include sections on theory, hypotheses, procedures / methodologies, results, and discussion. Theoretical articles should consistently justify the suitability of the selected sources for solving the chosen problem. The main sections of the analytical part are as follows:
 - a) research methods and conditions,

b) research results and their discussion.

- 6. **Conclusions** should structurally reveal the essential results obtained in the research, and in the case of empirical research, the activities performed should be emphasised.
- 7. Recommendations (if applicable).
- 8. **References.** It is recommended to refer to scientific publications published in the last 5 years and provide at least 10 reference sources. References should be described according to international APA 7 (*American Psychological Association*) rules. Textbooks, brochures, popular journals, marketing leaflets, students' papers and similar sources may not be used or cited. In the article, references should be indicated in brackets with the surnames of the authors and the year of publication, e.g., (Cooper, 2008), (Cleland, Kaufmann, 2012), (Kalnay et al., 1996). When the author is mentioned in the sentence, only the year should be indicated in brackets, e.g., "According to Dagėlienė (2010), ...".
- 9. If the article is written in Lithuanian, **the summary** and **keywords** should be written in English. If the article is written in English, the summary in Lithuanian should be provided. The summary in English should coincide with the abstract in Lithuanian (in content and the scope of 2000-2200 characters).
- 10.**Information about the authors**: name, surname. Name of the institution and the department, job position, and research field. Email address: name.surname@institution.xx

Formatting requirements

The article should be written in *Microsoft Word* format, typewritten on A4 (210×297 mm) size page, in one column, single-spaced, font *Times New Roman*, font size 11 pt., justified.

Other requirements:

- 1. Width of margins: top 2 cm, bottom 2 cm, right and left 2 cm.
- 2. First line indentation at 0.5 cm.
- 3. The article title should be written in bold, with a font size of 18 pt., and it should be centre-aligned.
- 4. Author's name, surname: in lowercase letters, bold font style, 12 pt font size, centre-aligned.
- 5. Name of the institution: in lowercase letters, italic font style, 10 pt font size, centre-aligned.
- 6. Abstract: title in bold font style, 10 pt font size; body text in 10 pt, no full stop after the last keyword.
- 7. Section titles: in lowercase letters, bold font style, 11 pt font size, left alignment.
- 8. The title **Reference list** should be written in 11 pt font size and the list of references in 10 pt font size.
- 9. **Tables and figures** should be numbered and named. They should be submitted in a separate document in an Excel spreadsheet. The title of the table should be written above the table, centre-aligned.
